DATES AND VENUES FOR PUBLIC HEARINGS ON ESKOM'S REVENUE APPLICATION FOR 2018/19

The National Energy Regulator (NERSA) will conduct public hearings on Eskom's revenue application for the 2018/19 financial year in all nine provinces between 20 October 2017 and 16 November 2017. Eskom has applied for a total allowable revenue of R219,514m. Eskom's total allowable revenue application translates to a 19.9% average increase in electricity tariffs.
